Flexible Work Allowance

Customize your work experience with a monthly **\$50 allowance (\$600 annually)**.



Time Off

- **Paid Time Off:** Start with 20 days of PTO in your first year. Additional days are added after you complete two and five years.
- **Holidays:** Enjoy **12 company-paid holidays** each year—including your **birthday** and two floating holidays.
- **Voting Time Off:** Take two hours of paid time off to vote in elections.
